Enrollment Information

Eligibility:

Dealers who sell rebate-qualified, energyefficient commercial food service equipment to DTE qualified customers are eligible for this program.

Payment:

Rebates and sales incentives are paid to dealer for qualifying equipment discounted to customer at the point-of-sale.

Support:
