Program Overview

The Instant Rebates! Point-of-Sale Food Service Program is now available to non-residential customers within LADWP territory in Southern California. The Program offers Instant Rebates for electric fryers, convection ovens, combination ovens, conveyor ovens and griddles.

Qualifying Equipment

Many makes and models of electric foodservice equipment qualify for rebates \$40 to \$5,000 per unit. Eligible equipment must be installed at an active, valid, non-residential electric LADWP service location in Southern California.
