Enrollment

Rebated equipment must be installed in a non-residential location that receives natural gas and/or electricity service from Puget Sound Energy.

Dealers must agree to all program requirements to participate and receive incentives.

Qualifying equipment

Many common makes and models of foodservice equipment qualify. Eligible equipment must be installed at an active, valid PSE non-residential service location.
