### Program Eligibility Requirements

- Participants provide Instant Rebates to customers at the point-of-sale with a line-item listed on the invoice as "California Instant Rebate".
- Rebated equipment must be installed in a non-residential location that receives natural gas and/or electricity service from SoCalGas®, Pacific Gas and Electric Company (PG&E®), Southern California Edison Company (SCE®) or San Diego Gas & Electric Company (SDG&E®).
- Dealers must agree to all program requirements to participate and receive incentives.

## Qualifying Equipment

Many common makes and models of commercial foodservice equipment qualify for the California Foodservice Instant Rebates Program. Qualifying equipment must be installed at a non-residential site that receives natural gas and/or electricity service from SoCalGas, PG&E, SCE, or SDG&E. The fuel type of the equipment being purchased must match the fuel type of the customer's non-residential account with one of the above utilities.
