Selling lighting for commercial projects in Seattle City Light or Snohomish PUD territory? Check the tables below for instant discounts. Subject to the following requirements:

- Discounts are capped at 90% of the products' regular retail cost. End use customers must pay a minimum of the 10% of the products' cost. No other funding sources can offset the minimum 10% customer contribution.
- Lamps are limited to 1,000 units per product category per project site address, per day.
- Fixtures and standalone controls are limited to 75 units per product category per project site address, per day.
- Discounts valid for products sold through December 31, 2026 and claimed within 90 days of the sales date. Products must be installed within 30 days of the claim submission date.
- Products receiving discounts through the Lighting to Go program are not eligible to receive discounts through other utility programs.
- Discount columns are not cumulative. Products are only eligible for a discount as a non-controlled fixture, fixture with integral control, fixture with LLLC control, or standalone control for existing fixtures.
- Discounts are only available for existing structures; new construction projects are not eligible.
- Fixtures, except for recessed downlights, must be DLC listed.
- Recessed downlights must be ENERGY STAR® listed.
- Fixtures with integral controls must be DLC listed and have daylight dimming and occupancy sensing active.
- Fixtures with LLLC controls must have fixture listed by DLC, must have the LLLC control listed by DLC, and must have daylight dimming and occupancy sensing active.
- Interior standalone controls do not include wall switch type occupancy sensors.
- Product category limits apply to all wattages and all equipment part numbers within the same product category sold per project site address per day.
